

OFFICIAL RULES
RELAY 2x21 FRENCH RIVIERA MARATHON 2026

Rule 1 - Organization

The Marathon “2x21.1km” des Alpes-Maritimes Nice-Cannes is organized on November 8th, 2026, on the occasion of the Marathon des Alpes-Maritimes Nice-Cannes, by Azur Sport Organisation, association loi 1901, affiliated to the French Federation of Athletism (FFA).

Rule 2 - Course

The “2x21.1km” race runs along the same course as the Marathon des Alpes-Maritimes Nice-Cannes divided into 2 equal parts:

- Relay 1 : Nice – Antibes Juan les Pins > 21.1 km
- Relay 2 : Antibes Juan les Pins – Cannes > 21.1 km

The race start will be done at the same time of the individual Marathon, the November 8th, 2026 at 8.00 am, Promenade des Anglais in front of “Théâtre de Verdure” in Nice to finish on “le Boulevard de la Croisette” in Cannes. You can see the course on the website www.marathon06.com

Rule 3 – Start corral

The first runner, starting the race, will have the possibility to start in the corral he wants, depending on his level, between the 3H15 and the 5H corral. He will not be able to run from the first corrals (élite, preferential less than 3h, 3h). Every team who does not respect this rule will be put out of the race, during or even after the race.

Rule 4 - Subscriptions

The race is opened to all athletes licensed or not licensed borned in 2009 and before.

Prices* are the following:

- 85 € (for the whole team) for the first 500 registered (250 teams), or until June, 30th 2026 (11:59pm) at the latest
- 95 € (for the whole team) from 501st to 1000th registered (500 teams), or until September, 30th 2026 (11:59pm) at the latest
- 110 € (for the whole team) from 1001st registered (500 teams) or from October 1st 2026

* €1 for each registration will be donated to the “Banque alimentaire”

Registration includes, with the bib number used as a train ticket, a non limited access to the TER train service between Nice and Cannes, in both directions, the day of the race.

During the time of opening registrations, organisation will could be organize specials discounts about the price of registrations

Entries can be done online on www.marathon06.com or www.sport-up.fr

None application form will be accepted by phone.

Every file will systematically be refused if it did not include the following documents:

- Official application form completed,
- Payment of the entry fees (*payment by credit card or payable to Azur Sport Organisation*),
- A PPS certificate number still valid on November 8th, 2026, attesting that the participant has completed and validated their health prevention course.

All the necessary documents must be sent before October 25th, 2026 at midnight on line or to:

Rule 5 - Classification

3 classifications will be made at the end of the race: men team, women team, and mixed team. We remind you that some controls will be effectuated during the race to insure optimum race regularities. An intermediate classification will be also made at the half marathon, at the relay baton transmission area.

Rule 6 - Entries

Each entry is considered as non-transferable and final and implies full acceptance of the rules. No refund will be made. The registration transfers is allowed between members of a team until October 25th 2026. It must be notified and validated by the organisation. Any person retroceding his bib to a person without the organisation's agreement will be recognized as responsible in case of an accident arising or provoked by this person during the competition. The organisation is exempt from all responsibility in case of an accident in this type of situation. The bib of each runner must be entirely visible and worn during the whole race.

A competitor who would want to run another race of the event shall ask the modification by email at verosportup@gmail.com before October 25th 2026. If the entry is more expensive, he'll have to pay the difference. On the opposite, no refund can be asked if the new race is cheaper.

Rule 7 - Collection of the start numbers

The collection of the start bibs numbers will be effectuated the race preceding days, in the Running Expo Marathon situated in Nice. The start number will be handed over to the team responsible with the start number's voucher and an identity card. No bib number will be given individually in a team.

The start number's voucher will be:

- Available online on www.marathon06.com on the tab *Subscriptions*
- Sent by email by the organization to the personal address given by the competitor when the entry was effectuated.

None race number will be send by mail or given on the spot on November 8th, 2026 before the start race.

Bikes, pets and suitcases will not be allowed.

Rule 8 – Shuttle service

The bib number of each runner will give him an unlimited access to TER SNCF service, the race day, between Nice and Cannes, in both directions.

Rule 9 - Security

The organization and the prefecture of the Alpes-Maritimes will insure the security of the runners and the spectators during the event. Medical safety will be under control of a security association agree by the prefecture of the Alpes-Maritimes through security posts located on the race. Medical services may stop any competitor during the race for medical reasons.

Rule 10 – Refreshments posts

Refreshment and food posts are set up every 5km from the 5th km. The type of food proposed will be adapted regarding the sanitary context at the date of the race. Runners will be informed of it in the days preceding the race.

As a complement, water posts are set up every 5km from the 7.5th km.

Rule 11 - Limit race time

The time limit for completing the course is 6 hours. Here are the timing gates :

After the « end of race » vehicle has passed, competitors should respect the Highway Code and be considered “out of the race” and every runner will be put “out of the race” and the organisation will be exempt from all responsibility in case of an accident in this type of situation.

Rule 12 – Timing system

The timing system will be used for timing by a person affiliated to the FFA. Each team will receive a chip which will be activated in an automatic way when the start line will be crossed. The chip will be used as control system on different check point positioned on the course. Competitors failing to follow the course will be disqualified.

Rule 13 - Relay baton transmission

Each team will receive 2 individual bib numbers plus another in which the chip will be integrated. The organization will provide you a belt to tie the bib number, and runners will use this as the relay baton. The second runner will have to give back the belt to the organisation after the finishline.

Rule 14 - Insurances

Civil liability : The organization has taken out a civil liability insurance policy in accordance with current legislation. This contract insures against damage caused by members of the organization and every competitor from the French Riviera Marathon des Alpes-Maritimes Nice-Cannes. Written proof can be provided upon request.

Individual accident : The organization highly recommends to the runners who did not have personal insurance covering the corporal damages particularly for the non-licensed runners, to subscribe to an individual « insurance accident » for their participation to the race.

Material dommage : The organization disclaims all responsibility in the event of a damage (theft, breakage, loss, ...) subjected to the personal communities of runners, even if it is looked after. The runners couldn't backfire on the organization for all damages occasioned to their equipment. The subscription of an insurance to guarantee these risks is within eachone's province.

Rule 15 - Protection of personal pictures

15.1 Image Rights and Processing of Personal Data

By registering for the event, each participant expressly and irrevocably authorizes Azur Sport Organisation, as the data controller, as well as its partners, technical subcontractors, and rights holders, to capture, process, use, and distribute free of charge their name, image, voice, and athletic performance recorded during the event, on all current or future media (including print, audiovisual, digital, websites, social networks, streaming platforms, or mobile applications). This authorization is granted for worldwide use, for purposes of communication, promotion, marketing, commercialization, or archiving of the event, for the entire legal duration of copyright and related rights protection, including any extensions therefore.

15.2 Processing of Personal Data

As part of the event, personal data is collected and processed to manage registrations, timing, result display, and the distribution of visual content (photos, videos). These processing activities are carried out by the organizer or, where applicable, by its subcontractors acting on its instructions, in accordance with the GDPR.

To facilitate participant access to their visual content, the organizer may use a subcontracted service provider that implements facial recognition, algorithmic identification, or automated classification technologies. These processes are strictly regulated and implemented in a proportionate manner, in line with the stated purposes.

Facial recognition relies on the analysis of facial features, allowing for the unique identification of a participant. This involves the use of biometric data, which falls under special categories of data as defined by Article 9 of the GDPR.

This anonymized processing is strictly limited to the following purposes:

- Automated indexing of the participant's images and videos;
- Secure grouping of such content in a dedicated personal space.

It is only activated if the participant has provided explicit consent, collected at the time of registration. This consent is optional, may be refused without affecting participation, and may be withdrawn without justification up to 15 days before the event, and participants may choose to avoid the marked capture areas.

The processing is carried out exclusively by the subcontractor PhotoRunning, under a contract compliant with Article 28 of the GDPR. The processed biometric data is not sold, reused, or exploited for any other purpose, and is automatically deleted within a maximum of 90 days after the event ends.

Rule 16 – CNIL

According to the French law of January 6th, 1978 about information and freedom, you have a right to access and rectify any personal information about you saved in our files. Through us, you may have to receive advertisements from other companies or associations. If you do not want so, just write us and tell us your name and if possible your race number.

Rule 17 - Circulation

Bicycles, motorized vehicles and pushchairs are strictly forbidden on the course except for the organization staff.

Rule 18 - Aid, Accompanying Persons, Assistance

It is forbidden to use any outside assistance, whether through the use of certain equipment or by employing one or more accompanying persons. The use of devices for listening to music during the competition is permitted on the strict condition that they allow the participant to remain aware of their surroundings. The isolation from the environment provided by these devices, which prevents the identification of certain dangers, is a risk factor for the user and for third parties: emergency services, law enforcement, etc. GPS pedometers and heart rate monitors are not considered assistance. A medical examination carried out during the event by a member of the medical service designated by the organizer and clearly identified by armbands, vests, or similar distinctive means, will not be considered assistance.

Rule 19 - Withdrawal

Each runner who wants to abandon, will have to notify the organisation through the race security staff placed all along the route, or through food or water stations. He will then be able to come back to Nice or to go to Cannes using the train with his bib number as a train ticket. Each runner stopping the race will automatically and immediately provoke his team withdrawal, regardless of he is the first or the second runner. If he was doing the first part, his teammate won't be allowed to start running, as he won't be given the bib including the chip.

Rule 20 - Reward Ceremony

The Reward Ceremony organized in Cannes will reward the 3 first teams or men, women, and mixed. None reward will be delivered for age category. However each team who will cross the finish line in the previous delay time will receive a "finisher" reward.

Rule 21 – Pandemic event cancellation

If the event could not take place due to an ongoing pandemic (population lockdown, non-gathering rules, ...), the organization will then propose a postponement of registered participants to the following year or a refund of registered participants, the proportion of which will be defined depending on the date of cancellation.

Rule 22 – Major fact event cancellation

If the event were to be canceled for a case of absolute necessity or for a motive independent from the will of the organization, apart from the cases listed in the rule 21, the organization will then only propose a postponement of registered participants to the following year. No reimbursement of registration fees can be made and no compensation received.

Rule 23 – Wheelchair

The race is opened to wheelchair athletes, according to "Fédération Française handisport" rules. In agreement with those rules, "hand bikes", or "hand cycling", will not be allowed on the race. An anticipated start will be held at 7.57 am, 3 minutes before the elite start.

Rule 24 – Sustainability

Through his races, Azur Sport Organisation is committed in sustainability. Runners participating to ASO races accept those commitments, and may consult it on the Internet website www.marathon06.com

Each runner seen throwing his garbages on the floor instead of the bin will be disqualified.

Rule 25 – Rules modification

The organization has the right to change those rules at any moment, and whatever the reasons. Registered people would then be informed of those changes by all possible means at the disposal of the organization.

Rule 26 – Sanitary rules

Regarding the sanitary rules, the organization will follow the governmental instructions in place at the date of the race, setting up all the necessary measures in order to offer a maximal protection for the runners, volunteers and to all the people involved in this event.

Then, and according to the rule 25, this competition rule sheet could be modified. Participants will anyway be informed of all sanitary measures and specifications before the event, and will have to conform to it if they want to take part to the race.

The participation to the 2x21.1 Marathon des Alpes-Maritimes Nice-Cannes implicates the express approval of the official regulation by every runner.
